QUINTA DA TORRE undertakes to guarantee the confidentiality and privacy in the collection and processing of the data of its Clients and Users, fulfilling its obligations under the General Regulation on Data Protection, having for that purpose developed this Policy of Privacy.

General scope:

QUINTA DA TORRE is responsible for this Privacy Policy. The present covers this website, as well as other sites, microsities, forms and documents that mention the said policy.

Within the scope of this Privacy Policy, QUINTA DA TORRE defined as:

Customer: any entity that purchases our products; and

User: any visitor to this website, as well as other sites and microsities that mention the said policy.

QUINTA DA TORRE reserves the right to update or modify its Privacy Policy at any time, in particular, in order to adapt it to legislative changes. The user is thus advised to visit this page regularly.

Consent:

By using this website, you are giving your consent for the collection and use of the information.

QUINTA DA TORRE may at any time modify, add or delete any of the privacy policies of its website (<https://www.quintadatorre-obidos.com>) by updating the content of this page.

Data collected:

QUINTA DA TORRE collects data from its Customers and Users, by submitting existing forms for this purpose, in digital and / or physical format.

QUINTA DA TORRE is the entity responsible for collecting and processing this data, deciding the categories of data collected, how it is treated and the purposes it will provide.

All procedures performed in an automated and non-automated way that allow the collection, organization, storage, modification and transfer of personal data will be considered as "processing of personal data".

Use of data:

The data collected by QUINTA DA TORRE are intended for the communication process with Clients and Users, processing requests for information and statistical analysis.

QUINTA DA TORRE may use your personal data to send you any junk e-mail related to products or commercial offers that may be of interest to you. QUINTA DA TORRE does not sell or trade your data.

QUINTA DA TORRE will not market or share its customer database with third parties.

Access to data:

QUINTA DA TORRE does not disclose to third parties any personal data of its Customers and Users, without its consent, except (1) when dealing with Group companies, or (2) when it is necessary for employees, employees, suppliers or commercial partners of QUINTA DA TORRE can provide a product or service or perform a function on behalf of QUINTA DA TORRE, or (3) when required or permitted by law.

QUINTA DA TORRE shall take reasonable precautions to ensure that its employees or employees with access to personal data are adequately trained in their correct processing, with respect to this policy and legal data protection obligations. In the event of non-compliance, QUINTA DA TORRE will apply disciplinary sanctions to its employees and employees.

Whenever QUINTA DA TORRE discloses your personal data, you will safeguard compliance with the Personal Data Protection Law, namely by providing contractual provisions that ensure that the third party uses the data received only for the purposes specified, and in accordance with for the purposes described in this policy, and makes use of appropriate means of security, in order to protect the user's personal data against illegal or unauthorized treatments as well as against their accidental loss, destruction or other harmful actions.

Data storage:

QUINTA DA TORRE stores data for its customers and Users on its servers located in Portugal. These servers are protected and maintained in accordance with high standards of security and in order to comply with the applicable privacy laws.

Data Storage Time:

The period of time for the storage and preservation of the personal data of Customers and Users of QUINTA DA TORRE varies according to the purpose.

The personal data of the Users of our website and microsites will be preserved until they remain active and are deleted for the purpose of this use.

The personal data provided for our mailing list distribution will be stored until the end of its use. In this case, Customers and Users may cancel, at any time, the subscription of the alerts through the option of cancellation provided in the Newsletters.

Client data and other specific data to be kept for compliance with QUINTA DA TORRE's legal obligations may be extended for a maximum period of up to 10 years (in accordance with article 130 of the Corporate Income Tax Code), at the end of which they will be eliminated.

Data security:

QUINTA DA TORRE has taken the necessary technical and organizational measures to adequately protect its data regarding unauthorized processing and access.

QUINTA DA TORRE makes every reasonable effort to prevent the unauthorized or illegal use of the user's personal data, as well as its loss, destruction or damage. However, QUINTA DA TORRE can not provide an absolute guarantee regarding the data of the User. Whenever there is an escape, loss or violation of personal data that is likely to pose a high risk to the rights and freedoms of its Customers and Users, QUINTA DA TORRE will:

Notify, within 72 hours after being informed of the event, the control authorities;

Communicate the situation to the affected data owner (s) in a timely manner.

QUINTA DA TORRE guarantees the security of the user's personal data through the following means: (1) use of encryption with certificate in all communications of the website, (2) use of password to access the website; and (3) limitation of access to personal data (for example, access only to QUINTA DA TORRE employees or workers who need to access them for the purposes described above).
